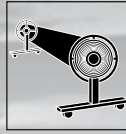

# Full Terms and Conditions



The following outlines the terms and conditions for the Swimming Pool/Spa Cover Rebate. Under SA Water's H<sub>2</sub>O ME REBATE scheme available from 28th September 2009.

## Eligibility

- 1) People eligible for the rebates include homeowners, private tenants, South Australian Housing Trust tenants (including non SA Water customers) who have purchased eligible products on or **after 28 September 2009**.
- 2) The rebates are not available for industrial and commercial purposes, including resale. The rebates are not available to strata companies or managing agents, commercial home builders or land developers.
- 3) The H<sub>2</sub>O ME REBATE scheme replaces the existing SA Water and South Australian Government Drought Response Scheme and the Rainwater Tank and Plumbing Rebate Scheme.

## General

- 4) For products that have been purchased through lay-by the rebate is available only if the final payment has been made on or **after 28 September 2009**.
- 5) Rebates are not available for rented, leased or hired products. Products that form part of all insurance claim are not eligible for rebates.
- 6) Second hand items will only be rebated from a registered business with an ABN. Receipt/ tax invoice and must be attached as proof.
- 7) The applicant must provide original receipts/tax invoices to be eligible for the rebates. It is the applicant's responsibility to make their own copy for their personal records as receipts/tax invoices will only be returned upon request. Application forms will not be accepted if they are incomplete or do not have the original receipts/ tax invoices attached.
- 8) SA Water will not be responsible for items lost or delayed in the mail, nor any remittance delayed due to incorrect rebate applications.
- 9) SA Water reserves the right to conduct field inspections to verify your claim. In the event that SA Water finds the applicant in breach of these terms and conditions, the rebate amount will need to be repaid to SA Water.
- 10) The applicant agrees and acknowledges that SA Water accepts no liability for the performance, quality or installation of equipment eligible for this rebate. The applicant agrees that they will indemnify SA Water for any liability or claim arising in relation to a product they have installed in order to claim a rebate.

- 11) SA Water and its employees have taken all reasonable care to accurately and correctly convey the scope of the H<sub>2</sub>O ME REBATE scheme and of the applicants entitlements under the scheme, and shall not be liable for any inadvertent errors. Furthermore SA Water does not assert that the scheme is in all cases appropriate for every resident.
- 12) SA Water reserves the right to alter or change the terms and conditions of the H<sub>2</sub>O ME REBATE scheme or to cancel the rebate scheme at any time.
- 13) Information provided on the application form may be used to measure and monitor the success of the scheme. Rebate recipients consent to and recognise that SA Water may contact them to conduct research about the products purchased.
- 14) The applicant's personal information will only be used or disclosed for purposes relating to the H<sub>2</sub>O ME REBATE scheme in accordance with the State Government Information Privacy Principles. If you wish to update or access the information that we hold about you, please contact us.
- 15) The Pool/Spa cover must be a Smart Approved WaterMark product. Please refer to the link for further information [www.smartwatermark.org](http://www.smartwatermark.org).
- 16) The pool/spa cover must be a minimum of 400 microns and be UV stabilised.
- 17) Solar blankets are eligible provided that they meet the criteria in clauses 15, 16, 18, 19, 20 and 21.
- 18) Rebates will only be given for the purchase of the cover if your pool was installed prior to the **23rd October 2006**.
- 19) The area of the pool/spa cover must be equal to or greater than the area of the pool itself for it to be eligible for a rebate. Where there is a pool and spa in one the cover must cover both to be eligible for a rebate.
- 20) Liquid pool covers are not an eligible product.
- 21) A copy of the approval from your local council or the company that has installed your pool is required for you to be eligible for a rebate and must be attached as proof.
