

WATER RESTRICTION PERMIT

NEW INSTANT LAWN

To register for exemptions from water restrictions to establish your new instant lawn call our Water Restriction Hotline 1800 130 952 and quote exemption code NL/L3E21 as well as the date for commencement of lay.

This exemption applies to Couch, Kikuyu, Buffalo and Paspalum (drought tolerant varieties) ONLY. At least 50% of existing lawn must be replaced or repaired for an exemption to be granted.

This permit is only valid for SA Water reticulated supply.

Ref No: NL/L3E21 **Expiration Date:** Twenty one (21) days after laying

The following special terms and conditions apply to this permit for use of sprinkler systems.

Failure to comply with these conditions renders the exemption invalid:

Instant Lawn

Instant lawn may be watered after the initial laying:

- Days 1 to 7 daily watering is permitted before 9am or after 6pm for 15 minutes per station.
- Days 8 to 14 watering is permitted before 9am or after 6pm on 4 occasions for 15 minutes per station.
- Days 15 to 21 watering is permitted before 9am or after 6pm on 3 occasions for 15 minutes per station.

On days when the temperature is to exceed 30 degrees, watering via a hand held hose fitted with a trigger nozzle is permitted. No watering is permitted if rain is forecast within 24 hours. Handheld hoses fitted with a trigger nozzle or drip irrigation systems may be used on any day for a maximum of 5 hours per week between the hours of 6am to 9am or 6pm to 9pm.

All future watering of the garden/lawn is to be in accordance with the current water restriction requirements. This exemption permit is applicable only for levels of restrictions up to and including Level 3 enhanced. Please note should the level of restriction increase this permit will be invalid.

In granting this permit SA Water encourages the holder to devise and implement ways wherever feasible to achieve a 20% or greater reduction in water use.

To ensure the terms and conditions of the permit are being adhered to, SA Water may conduct site audits. Therefore, please have this permit available for inspection at the site.

Daily watering via a hand held hose fitted with a trigger nozzle is permitted at anytime for 14 days after seeding only. No sprinklers are permitted.

All future watering of the garden/lawn is to be in accordance with the current water restriction requirements. This exemption permit is applicable only for levels of restrictions up to and including Level 3 enhanced.

Please note should the level of restriction increase this permit will be invalid.

In granting this permit SA Water encourages the holder to devise and implement ways wherever feasible to achieve a 20% or greater reduction in water use.

To ensure the terms and conditions of the permit are being adhered to, SA Water may conduct site audits. Therefore, please have this permit available for inspection at the site.
