# Full Terms and Conditions



The following outlines the terms and conditions for Hot Water Re-Circulator Rebate. Under SA Water's H<sub>2</sub>OME REBATE scheme available from 28th September 2009.

## Eligibility

- 1) People eligible for the rebates include homeowners, private tenants, South Australian Housing Trust tenants (including non SA Water customers who have purchased eligible products on or after 28 September 2009). Charitable organisations may be eligible for rebates for residential properties.
- 2) The rebates are not available for industrial and commercial purposes, including resale. The rebates are not available to strata companies or managing agents, commercial home builders or land developers.
- 3) The H<sub>2</sub>OME REBATE scheme replaces the existing SA Water and South Australian Government Drought Response Scheme and the Rainwater Tank and Plumbing Rebate Scheme.

## General

- 4) All receipts for eligible goods purchased must be dated on or **after 28 September 2009**. For products that have been purchased through lay-by the rebate is available only if the final payment has been made on or after **28 September 2009**.
- 5) Rebates are not available for rented, leased or hired products. Products that form part of all insurance claim are not eligible for rebates.
- 6) Second hand items will only be rebated from a registered business with an ABN. Receipt/ tax invoice and must be attached as proof.
- 7) The applicant must provide original receipts/tax invoices to be eligible for the rebates. It is the applicant's responsibility to make their own copy for their personal records as receipts/tax invoices will only be returned upon request. Application forms will not be accepted if they are incomplete or do not have the original receipts attached.
- 8) SA Water will not be responsible for items lost or delayed in the mail, nor any remittance delayed due to incorrect rebate applications.
- 9) SA Water reserves the right to conduct field inspections to verify your claim. In the event that SA Water finds the applicant in breach of these terms and conditions, the rebate amount will need to be repaid to SA Water.
- 10) The applicant agrees and acknowledges that SA Water accepts no liability for the performance, quality or installation of equipment eligible for this rebate. The applicant agrees that they will indemnify SA Water for any liability or claim arising in relation to a product they have installed in order to claim a rebate.

- 11) SA Water and its employees have taken all reasonable care to accurately and correctly convey the scope of the H<sub>2</sub>OME REBATE scheme and of the applicant's entitlements under the scheme, and shall not be liable for any inadvertent errors. Furthermore SA Water does not assert that the scheme is in all cases appropriate for every resident.
- 12) SA Water reserves the right to alter or change the terms and conditions of the H<sub>2</sub>OME REBATE scheme or to cancel the rebate scheme at any time.
- 13) Information provided on the application form may be used to measure and monitor the success of the scheme. Rebate recipients must consent to and recognise that SA Water may contact them to conduct research about the products purchased.
- 14) The applicant's personal information will only be used or disclosed for purposes relating to the H<sub>2</sub>OME REBATE scheme in accordance with the State Government Information Privacy Principles. If you wish to update or access the information that we hold about you, please contact us.
- 15) To be eligible for the heated water re-circulator rebate the re-circulator must be connected to the entire heated water system, individual fixture connection will not be eligible for a rebate.
- 16) The product selected must have Smart Approved WaterMark.
- 17) Plumbing work and associated costs are not eligible for a rebate. Rebate applies to unit only.
- 18) SA Water will only pay one rebate per property to a maximum of \$150.
- 19) The original receipt/tax invoices stating the date, place of purchase, make and model of the Heated Water Re-circulator, purchase receipt number and showing payment in full is required to receive this rebate.
- 20) The Heated Water Re-circulator must be installed by a licensed plumber and the application must be submitted with an SA Water Certificate of Compliance from the licensed plumber attached.
- 21) It is the applicant's responsibility to ensure that the plumber is appropriately licensed to complete the plumbing work and issue a SA Water Certificate of Compliance.
- 22) Tenants need to provide a written letter of permission from their landlord with the application to be eligible for the rebate.
