

## **TERMS AND CONDITIONS SOUTH AUSTRALIAN WATER CORPORATION - BPAY ACCOUNT PAYMENT COMPETITION**

By entering the SA Water BPAY account payment promotion you are agreeing to the following terms and conditions:

### **1. INTERPRETATION OF RULES.**

- 1.1. In these rules: "SA Water" means South Australian Water Corporation; "customer of SA Water" means a person named on a bill for water rates and charges issued by SA Water.
- 1.2. Information on how to enter forms part of the terms and conditions of entry.

### **2. WHO CAN ENTER**

- 2.1. Subject to clauses 2.2 and 2.3, entry is open to all residential customers of SA Water who;
  - 1) are at least 18 years of age, and
  - 2) are a customer of SA Water
- 2.2. Employees of SA Water and members of their immediate family are not eligible to enter.
- 2.3. For the purposes of clause 2.2 a person is a "member of the immediate family" of an SA Water employee if the person:
  - 1) is the spouse of an SA Water employee;
  - 2) is a dependent child of an SA Water employee;
  - 3) resides in the same household as an SA Water employee.

### **3. COMPETITION PERIOD**

- 3.1. The competition commences at 9:00am Australian Central Standard Time on 1 October 2011 and ends at 5:00pm Australian Central Summer Time on 31 January 2012 ("the Competition Period").

### **4. HOW TO ENTER**

- 4.1. In order to enter, residential property owners must make a payment against their SA Water account via BPAY which must also be received by SA Water within the Competition Period.
- 4.2. Entries are limited to one entry per residential property owner per property. For example,
  - 4.2.1. 1 property: 1 entry is recorded, regardless of the number of BPAY payments made against this property during the Competition Period.

4.2.2. Multiple properties: one entry is recorded per property, regardless of the number of BPAY payments made against the individual properties during the Competition Period.

4.3. Entries received after the Competition Period ends are ineligible.

## **5. PRIZES**

5.1. The first 4 correct entries drawn will receive a Commonwealth Bank pre-paid credit card to the value of \$500.

5.2. The total prize value is \$2,000.

5.3. SA Water accepts no responsibility for any variation in prize value.

5.4. No component of a prize may be transferred or redeemed for cash.
