

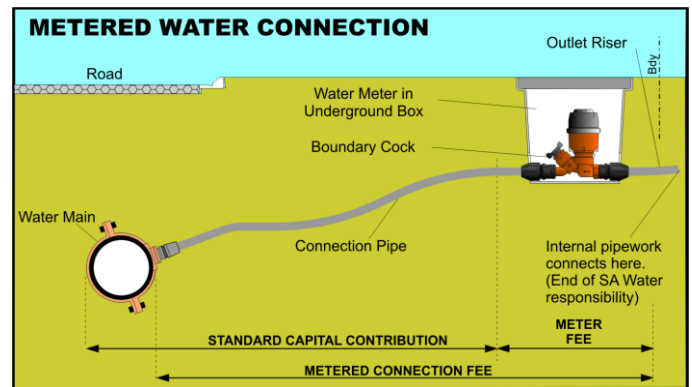
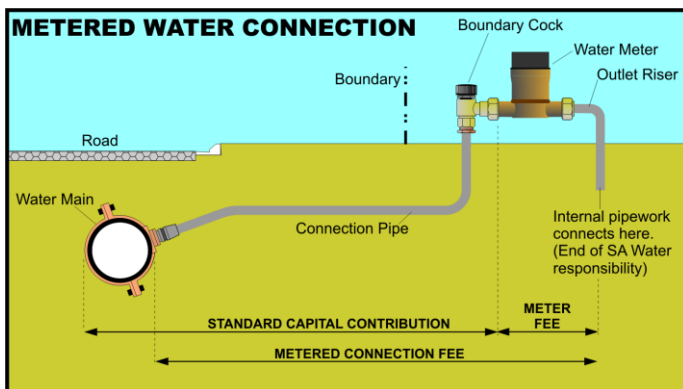
Information Sheet

Metered Recycled Water Connection

SERVICE

If your allotment is located within an area that has a dual water supply system, you will be required to apply for 2 separate metered connections. A drinking water connection and a recycled water connection (for irrigation and toilet flushing requirements). If water mains are available and SA Water can provide connections, SA Water will endeavour to construct metered connections within 15 business days of your payment, for connection sizes up to 50mm.

Above Ground Connection

Service options for meter sizes are 20mm and 50mm (subject to approval). The recycled water connection is lilac (purple) coloured and clearly marked

“WATER NOT SUITABLE FOR DRINKING”.

Below Ground Connection

You may like to protect and cover the water meter(s) using our metal underground box, subject to approval.

Plumbing Requirements

- If you are building a new dwelling, a licensed plumber is usually required. At the same time that you make payment for a metered connection we suggest that you contact a plumber (if required) to arrange for the water connection from the water meter to your premises. Plumbing costs should be factored in when you are estimating the cost of providing water to your premises. This will allow the plumber to schedule work to be undertaken as close as possible to the time that the water meter is installed. The licensed plumber is to notify SA Water via the plumbing booking system by calling 1300 884 055 or using plumbooking.sawater.com.au prior to concealing any pipes or fittings associated with the recycled water connection. The pipework will be subject to an inspection by SA Water.
- Most major building companies within South Australia include installing a 20mm water meter (located on the property) in their standard contract. Any variations to the meter installation charge, such as a metered connection or below ground box are normally not covered by the standard building contract.
- The licensed plumber is required to clearly identify the recycled water connection. The meter, valves, piping and hose taps are lilac (purple) coloured conforming to AS 2700 and clearly marked with a metallic sign indicating “WATER NOT SUITABLE FOR DRINKING”.

Recycled Water Uses

Recycled water is delivered through a separate pipe system from your regular drinking water supply. Recycled water is to be used only for the following purposes.

- Watering gardens
- Flushing toilets
- Washing vehicles / boats

It's important there is no cross-connection between the recycled and drinking water services on your property. If you have any plumbing, building or landscaping works undertaken, you should ask your contractor to make sure the systems are operating for the correct purpose once the work is complete. A plumber making any alterations to your pipework must provide you with a Certificate of Compliance and notify SA Water to have that work audited.

Information We Need From You

- Your name, postal or email address, fax and phone number.
- Your property address and owner's name.
- A plan showing where the meter is required on your property. Construction cannot take place until a plan is received by SA Water. The default position of 0.4 metre from a side boundary will apply. All meters are laid between 0.5 metre and 0.6 metre inside the property boundary.
- You will need to advise us of any possible site obstructions, such as large trees or stobie poles, electricity or gas boxes, site toilet, rubble, brick letter box, etc. Additional costs may be incurred if the connection cannot be constructed in the position nominated.

20mm Meter

Applications Requiring Approval

- A second 20mm meter or a 50mm meter.
- If the meter is larger than 20mm, a Survey/Building plan may be required.
