# **Funding Secured for IPOS Review and Upgrade**

Local Government Turf and Irrigation Technical Group awarded funding to review and update the IPOS Code of Practice

The Local Government Turf and Irrigation Technical Group (LGTITG) is made up of local councils, relevant industry associations and relevant government departments. The group meets quarterly to discuss issues impacting the management of open space. The LGTITG was the major driver behind the development of the original IPOS Code of Practice. The LGTITG has appointed a smaller project steering group that is overseeing the review of the original IPOS CoP. This project aims to incorporate models for forecasting irrigation demand, a star rating scheme and accreditation model for managers of open space. The tender has been awarded to a private consultant to deliver the project. Ninety thousand dollars funding has been provided by the Department of Environment, Water and Natural Resources (DEWNR) as well as the Adelaide Mount Lofty Ranges and Murray Darling Basin Natural Resource Management (NRM) Boards.

The new and updated IPOS CoP will incorporate some great outcomes for Open Space Managers including;

- A report on the original findings of the review including results of investigations and industry consultation
- Preparation of 2<sup>nd</sup> edition of 'The Code of Practice Irrigated Public Open Space' incorporating outcomes of the review.
- An 'IPOS Accreditation System' that is structured to enable organisations to progress to a level of best practice irrigation management.
- A concise 'IPOS Support Tool' that will enable practitioners to grasp the critical concepts of irrigation management and apply them with a degree of confidence.

The project is scheduled to finish in this financial year and will therefore be ready and available for the following irrigation season in the next financial year!
