
New IPOS Code of Practice now available

Comprehensive IPOS CoP available in hard copy and electronically

Following the launch and release of the new IPOS Operational Guide, the reviewed and updated new comprehensive IPOS Code of Practice is available here.

The Code of Practice was supported by a wide range of industry professionals and funded through the Department of Water and Natural Resources (DEWNR), Adelaide and Mount Lofty Natural Resource Management Board (AMLR) and Murray Darling Basin Natural Resource Management Board (MDB).

The revised Code provides a template that can be used by open-space managers to ensure planning, management and reporting of water consumption in the urban environment is based on sound principals applied consistently across all levels of management.

Office for Recreation and Sport Leak Analysis Project

Sporting clubs benefit from water meter data logging project

In October 2015, the ORS engaged SA Water to deliver a Leak Analysis and Water Profiling project supporting some councils and sporting clubs improve their water management through utilising data logging technology to better understand how water is used on their site.

The project involved attaching data loggers to agreed water meter(s) and logging water consumption at two minute intervals for a defined period.

The analysis on the majority of sites revealed some form of continuous flow through the water meters for extended periods, indicating that leaks may be present. For example, a significant continuous flow was identified at Globe Oval in Port Pirie of approximately 4 litres per minute. The site was notified and after investigation a leaking irrigation pipe was identified



and repaired. If the leak was left undetected, the costs of the wasted water could have been in excess of \$20 per day or over \$7000 per year. It was fortunate that Port Pirie Council staff were able to act quickly.

The project has reinforced the need for larger water consumers to:

- Read meters regularly or deploy smart meters to do this for you
- Investigate opportunities that will lead to cost savings, such as:
 - o Access to recycled water where feasible
 - Upgrade to more efficient irrigation systems
 - o Invest in smart metering technology
- Ensure irrigation is scheduled appropriately do not set and forget!
- Maintain irrigation systems and regularly check for leaks by observing greener and/or damp spots
 on your turf as well as checking sprinkler heads and solenoid valves
- Regularly check clubroom amenities for leaks and repair quickly.

Tip of the Month

If you are using a water source that is not SA Water supplied drinking water to irrigate such as a bore or recycled water, it is worth periodically obtaining a water sample to determine the salinity as well as other important parameters to analyse the suitability of the water. Table 5.5 on page 33 on the new IPOS Code of Practice provides information on the desirable properties of water used for irrigation.
