Freedom of Information – Determination

I refer to your application made under the South Australian Freedom of Information Act, 1991 ("the Act") received by SA Water on 14 February 2019, seeking access to:

"All documents, minutes, briefings, emails, notes and agendas relating to meetings between SA Water and the Minister for Environment and Water" – Date range 19/03/2018 to 13/02/2019.

SA Water has identified 76 documents that fall within the scope of your request. Based on my assessment of the documents, I have determined to provide you access to 55 documents, partial access to 20 documents, and refuse you access to one document, as outlined in the attached document schedule.

Section 20 of the Act provides that an agency may refuse access to a document, or sections of a document, if the information is considered exempt pursuant to the provisions listed under Schedule 1 to the Act. The documents and sections of documents which I consider exempt and the reasons for the exemption are explained in more detail below.

Clause 1(e) of the Act states:

1-Cabinet documents

- (1) A document is an exempt document—
 -
 - (e) if it contains matter the disclosure of which would disclose information concerning any deliberation or decision of Cabinet;

Clause 1(e) exists to protect the confidentiality of deliberations and decisions of Cabinet which are considered necessary for effective government. SA Water has identified multiple copies of minutes of meetings between the Minister for Environment and Water and various other attendees, 15 of which contain sections recording discussion regarding the deliberations or decisions made by Cabinet. Based on the protections provided by clause 1,1 have determined that sections of these documents are exempt from release pursuant to clause 1(e) of Schedule 1 to the Act.



Clause 6(1)(a) of Schedule 1 to the Act states that:

6—Documents affecting personal affairs

(1) A document is an exempt document if it contains matter the disclosure of which would involve the unreasonable disclosure of information concerning the personal affairs of any person (living or dead).

SA Water has identified 13 documents which contain the personal email address details of several individuals. Given the unrestricted public access that is afforded to a document once determined for release under the Act, I consider the disclosure of personal email address details to be unreasonable. Therefore, I have determined that sections of these documents are exempt from release pursuant to clause 6(1) of Schedule 1 to the Act.

Clause 7(c) of Schedule 1 to the Act states that:

7-Documents affecting business affairs

- (1) A document is an exempt document—
 - 12.52
 - (c) if it contains matter—
 - (i) consisting of information (other than trade secrets or information referred to in paragraph (b)) concerning the business, professional, commercial or financial affairs of any agency or any other person; and
 - (ii) the disclosure of which—
 - (A) could reasonably be expected to have an adverse effect on those affairs or to prejudice the future supply of such information to the Government or to an agency; and
 - (B) would, on balance, be contrary to the public interest.

Document 49 is an email exchange between the Chair of the SA Water Board and the Minister for Environment and Water, providing strategic advice regarding South Australian water industry export opportunities for the Minister's consideration prior to the water export round table meeting. Disclosure of this document would jeopardise the Government's approach to export development and international market opportunities by providing competitor insight into areas of export capabilities. Access to attractive market opportunities would lead to an increase in interstate and overseas competition, resulting in a decrease to South Australia's market share.

Clause 7(1)(c) requires that I consider the balance of public interest factors when determining the release of this documentation. I have weighed the public interest factors in favour of disclosure, including the objects of the Act and transparency in communications between SA Water and the Minister's office. However, in my view, this is outweighed by the adverse effect disclosure will have on the South Australian water industry export opportunities and the impact this would have on the water industry's contribution to South Australia's economic growth. It is for this reason that I consider disclosure of document 49 is, on balance, contrary to the public interest.

If you are dissatisfied with this determination, you are entitled to exercise your rights to internal review and appeal as outlined under Section 29 of the Act. To apply for an internal review you must lodge an internal review application form with SA Water within 30 days from the date of this determination. Internal review applications should be addressed to the Principal Officer, GPO Box 1751, Adelaide SA 5001.

In accordance with the requirements of the Premier and Cabinet Circular PC045, details of your FOI application, a copy of this notice of determination, a schedule of documents and the documents to which you have been given access, will be published on the SA Water website FOI disclosure log. 

Master Builders is SA is concerned that a recent policy decision by SA Water will have a negative impact on housing affordability. We are interested to discuss a potential solution.

SA Water has recently amended its developer agreement, introducing a new requirement that SA Water and all third parties undertaking civil infrastructure works that will be handed over to SA Water need to be named on the developer's Public Liability Insurance policy.

I understand this is a whole of industry change.

Previously, our members have required all contractors and subcontractors that they engage to undertake any development /civil works to hold their own public liability insurance.

Following this SA Water amendment, the insurance industry has advised that the inclusion of such contractors alters a builder's "risk rating", and could significantly increase their annual premium. These extra charges will be passed on and this will affect the cost of land and in turn housing affordability.

A proposed solution to mitigate this risk for SA Water and minimise any potential insurance premium increase would be to:

- just name SA Water on the builder's Public Liability insurance , and
- amend the SA Water Developer Agreement to ensure all contractors also name SA Water.






