Freedom of Information – Determination

I refer to your application made under the South Australian *Freedom of Information Act, 1991* ("the Act") received by SA Water on 10 July 2018, seeking access to:

"A list of all Freedom of Information requests received from the Liberal Opposition between 17 March 2014 and 16 March 2018."

SA Water has identified four documents that fall within the scope of your request, as outlined in the attached document schedule. Based on my assessment of the documents, I have determined to provide you with full access to these documents.

If you are dissatisfied with this determination, you are entitled to exercise your rights to internal review and appeal as outlined under Section 29 of the Act. To apply for an internal review you must lodge an internal review application form with SA Water within 30 days of this determination. Internal review applications can be addressed to the Principal Officer, GPO Box 1751, Adelaide SA 5001.
