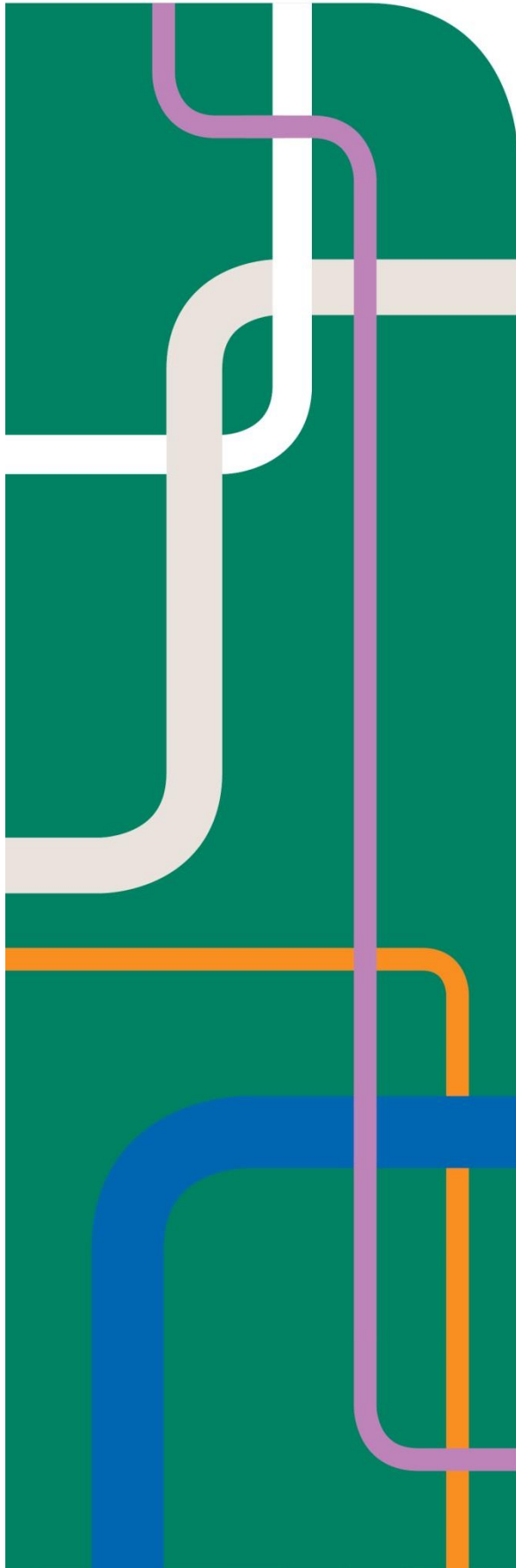



This document specifies products that are authorised for use in packaged sewer pumping stations that are installed in sewer systems.


NOTE: Authorised products for use in pumping mains (from Pumping Stations) up to a maximum size of DN 200 are detailed in TS 0502.

3 Package Pump Station Information

All Fittings Shall Comply With Australian Standard	AS 1260 AS 2032
Specification	
Notes	<ul style="list-style-type: none"> • All package pump stations shall be in accordance with the Sewer Construction Manual (Section M), the Authorised Manufacturer Approved Drawing, and the Approved Design Drawings. • Approved Supplier Pumping Stations come as a Package, inclusive of a concrete sump, separate concrete valve chamber, electrical cabinet and vent. • Pumping Stations Sump shall be installed complete with covers, mechanical plant and equipment, pump bases, guide rails, pipework, level control mechanisms, lifting chains and all ancillary items. • Safety railing is a requirement. • Stations installed in highly corrosion environments shall require all steel items installed inside chamber to be Grade 316 Stainless Steel or other non corrosive materials as approved by SA Water. This includes the Pumps, Guiderrails etc. • Manufacturers are presented in alphabetical order. (Refer Disclaimer).


